## About the Authors

*Paul E. Gold* is Professor of Psychology and Neuroscience and Director of the Medical Scholars Program at the University of Illinois, Urbana-Champaign. After receiving his Ph.D. from the University of North Carolina at Chapel Hill in 1971, he was a postdoctoral fellow at the University of California, Irvine, and then joined the faculty of the University of Virginia, where he served as Director of the Neuroscience Graduate Program. After a year at SUNY-Binghamton, he moved to his current position at the University of Illinois. The focus of his research is on regulation of memory formation by hormones and brain neurotransmitters. He is a fellow of the American Psychological Association, the American Psychological Society, and the American Association for the Advancement of Science. He is editor of *Neurobiology of Learning and Memory* and has served on editorial boards of numerous other journals.

*Larry Cahill* is an Assistant Professor of Neurobiology and Behavior and Fellow of the Center for the Neurobiology of Learning and Memory at the University of California, Irvine. He received a Ph.D. from Irvine in 1990 and then conducted postdoctoral work at the Technical University in Darmstadt, Germany, for 2 years before returning to Irvine to extend his studies of emotion and memory. In 1997 he received a faculty appointment in the Department of Psychobiology (now Neurobiology and Behavior). Cahill's research integrates neuropharmacological, neuropsychological, psychophysiological, and human brain-imaging approaches, together with animal research, all focused on how emotional arousal modulates memory storage. He is a reviewer of manuscripts for more than 40 journals and serves on the History of Neuroscience Committee of the Society for Neuroscience.

*Gary L. Wenk*, Professor of Psychology and Neurology at the University of Arizona, received a Ph.D. from the University of Cincinnati in 1980. He was a postdoctoral fellow at the Albert Einstein College of Medicine before joining the faculty of the Johns Hopkins University and then serving as a Program Director for the Division of Behavioral and Neural Sciences, National Science Foundation. He moved to the University of Arizona in 1990. He is a member of the Autism Think Tank Group of The Autism Research Foundation at Harvard University and serves on the Brain Disorders and Clinical Neuroscience study section at the National Institutes of Health. Wenk's research is focused on drugs that can enhance cognitive function or rescue brains from the consequences of aging. He has served on the editorial boards of *Behavioral Neuroscience* and *Psychobiology* and as an expert consultant to numerous pharmaceutical companies.

*Mark A. McDaniel* is Professor of Psychology at the University of New Mexico. He received his Ph.D. in experimental psychology from the University of Colorado in 1980. His focal research interests include encoding and retrieval processes mediating recall, prospective memory and aging, and learning of complex concepts such as intervening and function concepts. He has authored more than 100 publications, and for the past 15 years his work has been supported by the National Institutes of Health and by the National Aeronautics and Space Administration. He was president of the Rocky Mountain Psychological Association, has served on numerous editorial boards, and is former associate editor of the *Journal of Experimental Psychology: Learning, Memory, and Cognition*.

*Steven F. Maier* is University of Colorado Distinguished Professor and a member of the Department of Psychology and Director of the Center for Neurosciences. He received his Ph.D. in psychology from the University of Pennsylvania in 1968. His primary research interests are the neurochemistry of stress, brain-immune system pathways and relationships, and the implications of these pathways for understanding stress, mood, and cognition. He has received numerous awards, is the author of more than 250 scientific publications, is on numerous editorial boards (including the boards of *Brain, Behavior, and Immunity* and *Molecular Psychiatry*), and currently holds four research grants from the National Institutes of Health.

*Gilles O. Einstein* is Professor and Chair of the psychology department at Furman University. He received his Ph.D. in experimental psychology from the University of Colorado in 1977. His current research focuses on understanding how people remember to perform intended actions (prospective memory). He has more than 50 publications, and his research has been supported by the National Institute of Mental Health, National Institute on Aging, and National Aeronautics and Space Administration. He is a fellow of Division 20 of the American Psychological Association and a member of the editorial board of the *Journal of Experimental Psychology: Learning, Memory, and Cognition*. He and Mark McDaniel are coauthors of a forthcoming book on memory and aging to be published by Yale University Press.
